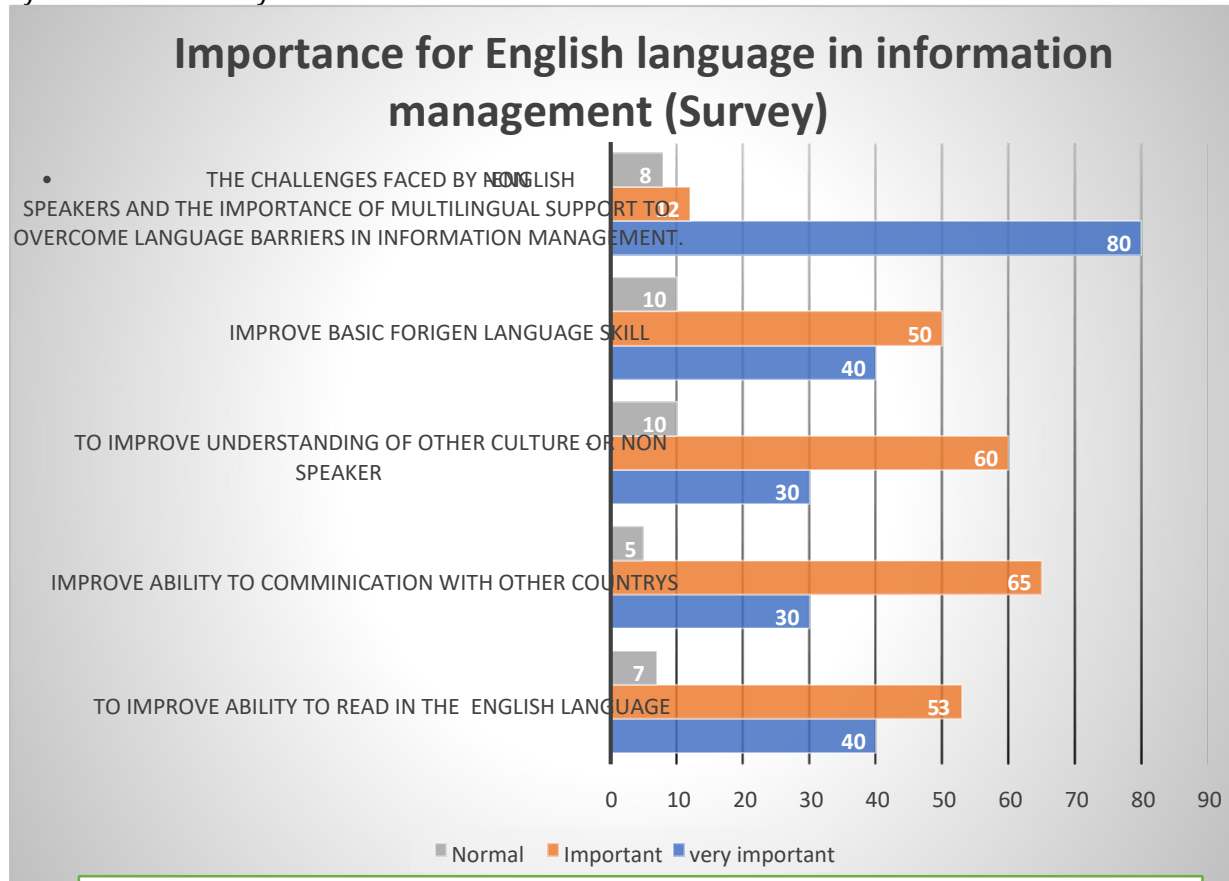


Figure. 1, Importance for English language in information management (Survey)

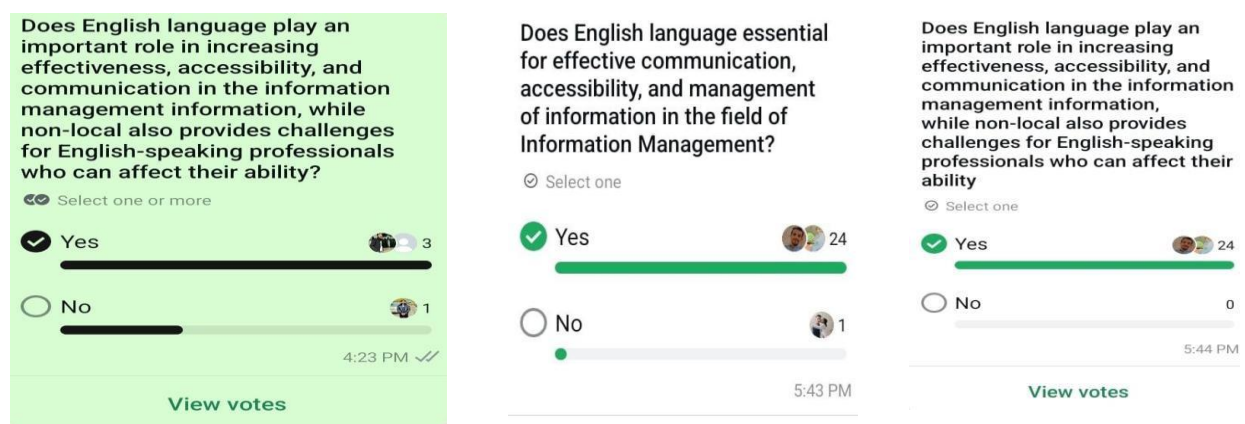


Figure. 2, Role of English language in information management (Survey)

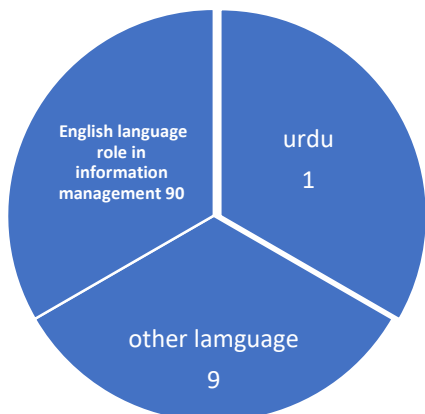
